Both parties acknowledge that as the outing dates approaches, both the total number of participants and overall needs of the event may change which will affect the final invoice price. This contract is to secure the date and set the basic price as stated in the Bunker Hill Outing Price Guide. The final invoice will be generated and due the day of the event.

The tournament group and event coordinator/chairpersons are responsible for the proper conduct and attire of all participants, use and care of the golf course and other facilities and equipment including golf carts. Please review the information on the following page, sign and return this contract to the Bunker Hill Pro Shop at the address above.

Please return signed contract and deposit by the deposit due date specified on the previous page or the event is subject to cancelation. Confirmation of players and other conditions specified below. Final payment is due on the day of the event.

This agreement is with Bunker Hill Golf Course located at 220 Bunker Hill Road, Princeton, NJ 08540 hereinafter referred to as "Bunker Hill", and the "Group" name listed above hereinafter referred to as "customer."

1. **GUARANTEE:** The customer is responsible for payment of guaranteed number of players as written in contract. Final menu selections and arrangements shall be estimated no less than fourteen (14) days prior to the tournament date and an appropriate number of players estimated given at that time. Customer shall advise Bunker Hill of final guaranteed number of players no less than seven (7) days prior to tournament date. If the final guaranteed number of guests is less than agreed upon minimum number of guests, the customer is responsible for payment of the minimum guaranteed number of guests. Management reserves the right to charge for damages in the event of a breach of this guarantee.
2. **DEPOSITS/CANCELLATIONS:** All deposits and payments are non-refundable unless agreed upon by both parties. In the event of customer contract cancellation, the customer shall be responsible for contracted revenues generated for the function including all charges, gratuity and taxes. Bunker Hill will make every effort to re-book the space, and if the space is not re-booked at equivalent revenue, the customer shall be responsible for the difference.
3. **PAYMENT:** Payment shall be as follows: (a) A \$250 deposit at time of booking is strongly suggested to secure the requested date. Unless a deposit is waived, the deposit is required 45 days prior to the event otherwise the date will be released to the public for other events or daily play; (b) final payment must be made the day of the event in the form of a check, credit card or cash. Final payment is based on the final number of guests on a per person basis or by the Full Shotgun price as listed in the Bunker Hill Outing Price Guide. If the function is canceled, management will demand all damages stated in paragraph 2, including all legal fees. Gift Certificates or Gift Cards will not be accepted as payment for contracted events.
4. **LIABILITY:** Management will not be responsible for articles of clothing, customer supplied items or personal property lost, stolen damaged or left on the premises or for any damage or loss to parked cars. It is the responsibility of the customer to collect all items belonging to them at the end of the function. Customer is responsible for damages to any golf cars if occurrence takes place during the customer event.
5. **BEVERAGE POLICY:** Bunker Hill does not sell, allow or provide alcoholic beverages on the property. Conduct or actions by individuals attending customer event without the consent of Bunker Hill regarding the consumption of alcohol is the sole responsibility of the customer and/or event coordinator.
6. **TAXES AND GRATUITY:** Prices quoted are subject to New Jersey State tax and/or gratuities where applicable. The customer understands that appropriate amount will be calculated and added to the invoice total for payment. Taxes and gratuity are primarily for services or items provided by The Links Café / Pat Mar Co.
7. **CONDUCT OF EVENT:** (a) Customer and guests will confine themselves to the specific space rented and use such entrances and exits designated by Bunker Hill; (b) Customer assumes responsibility for any and all damages, losses and bodily injury caused by them or any of their guests or any other persons attending the function which are of a nature not acceptable to Bunker Hill or are not considered to not be proper golf etiquette; (c) Management reserves the right to cancel this agreement without notice and without liability in the event of a breach of this contract by the customer or when the rules were not observed or when functions are of a nature not acceptable to this establishment; (d) Management reserves the right to remove persons from the premises that management deems objectionable without any responsibility therefore to lessee.
8. **PACE OF PLAY REQUIREMENT:** Bunker Hill reserves the right to adjust a group's course position, eliminate holes to be played or remove the group altogether if that group's pace of play is deemed to be too slow or will be detrimental to the event finishing in their allotted time slot. The group will be allowed to return and finish any unplayed holes as Management or daylight permits. No refunds will be given or future considerations made to any specific group that is replaced or removed from any position on the golf course due to slow play.
9. **NOTICE:** This contract is binding upon the parties hereto, their respective heirs and representatives, successors and assigns, and this contract is governed under the rules of the State of New Jersey and is not assignable.
